Seminar on Good Practice for External Lighting Installations

Programme Highlights

The Government set up in 2011 the Task Force on External Lighting (“the Task Force”) to advise the Government on the appropriate strategy and measures for tackling light nuisance and energy wastage problems caused by external lighting, having regard to international experience and practices and the local circumstances. The Task Force published in April 2015 its report to the Government, which recommended a multi-pronged approach to tackle the problems caused by external lighting, including –

- The introduction of the Charter on External Lighting (“the Charter”) to encourage owners of and responsible persons for external lighting installations of decorative, promotional and advertising purposes which affect the outdoor environment, to switch off such lighting installations during the preset time of 11p.m. to 7a.m. or midnight to 7a.m.
- To re-launch the Guidelines on Industry Best Practices for External Lighting Installations (“the Guidelines”) to encourage the adoption of good practices in the design, installation and operation of external lighting installations.

The Seminar

The Government has accepted the Task Force’s recommendations and has launched the Charter took effect in April 2016. To promote good practices for managing external lighting installations, The Government appointed a consultant, Parsons Brinckerhoff, to provide suggestions and advice on ways to reduce light nuisance and energy wastage caused by external lighting through the organization of Seminars for professionals and trade involved in managing such installations. Issues to be covered include operating hours for lighting, controls for lighting, light nuisance control measures, energy efficiency measures, lighting project design planning and prevention of glare impact.
